In sum, as the volume shows, the high permeability of the demarcations between the State, the family and the market impedes a categorical approach. This volume is based on the general and selected national reports on the topic *Contractualisation of Family Law* that were presented at the XIXth International Congress of Comparative Law in Vienna in July 2014.
