Swastika over the Acropolis Craig Stockings, Eleanor Hancock, 2013-07-04 *Swastika over the Acropolis* is a new multi national account which provides a new and compelling interpretation of the Greek campaign of 1941 and its place in the history of World War II. It overturns many previously accepted English language assumptions about the fighting in Greece in April 1941 including for example the impact usually ascribed to the Luftwaffe German armour and the conduct of the Greek Army. Further *Swastika over the Acropolis* demonstrates that this last complete strategic victory by Nazi Germany in World War II is set against a British Dominion campaign mounted as a withdrawal not an attempt to save Greece from invasion and occupation.
