BUSINESS LAWS THE LAW ON CORPORATION

Corporation

an artificial being created by operation of law, having the right of succession and the powers, altributes and properties expressly authorized by law or incident to its existence.

Attributes of a Corporation:

- It is an artificial being.
 - Doctrine of piercing the well of corporate entity or corporate fiction.
 - This is the doctrine to the effect that the separate personality of a corporation may be disregarded if such entity is used to defeat public convenience, justify wrong, protect traud, or defend crime
- It is created by operation of law.
- It has the right of succession.
- It has the powers, attributes and properties expressly authorized by law or incident to its existence.
 - Doctrine of limited capacity

A corporation can exercise only the powers expressly conferred upon it by law and its articles of incorporation, those implied from such powers expressly granted, and those that are incident to its existence.

- As to their legal right to corporate existence.
 - a. De jure corporation
 - b. De facto corporation
- As to their relation to another corporation or other corporations.
 - a. Parent or holding corporation
 - One which owns the shares of another corporation and having power, directly or indirectly, over the latter including the election of the directors thereof.
 - Subsidiary corporation
 - One whose shares of stock are owned by another corporation, called the parent corporation, which has the power to elect its directors

 - a. Close corporation
 - Open corporation
- Other classifications
 - Corporation by prescription
 - Corporation by estoppels
