Trial vs. Appellate Courts

- Trial courts hear evidence (documents, witnesses) and decide initial result.
- Judge or jury may decide
- Appellate courts do not hear direct evidence; they review the record of the lower court to determine if a "reversible" (harmful) error has occurred
- Usually an error of law that was likely to affect the outcome
- Appellate court decisions become precedents for future cases
