
# Chinese economy bounces back into growth

The authors calibrate and predict different scenarios out to 2025 These scenarios are necessarily speculative but it is interesting that they typically imply negative net foreign asset positions between 3 and 9 percent of wealth What may be counter intuitive for many policymakers is that successful institutional reform and productivity growth are likely to lead to more negative net foreign asset positions than occurs with stagnation Starting from China's zero net foreign assets position it would take current account deficits in the range of 2.5 percent of GDP to reach any of these net foreign assets positions.
