practical implementation of these laws was initially blocked by Soviet federal ministries, their formal existence in the books enabled Yeltsin to move more quickly towards liberalization of the economy after the Soviet Union collapsed. As a result of Yeltsin's subsequent problems with his own legislature in 1992, which seriously impaired his reforms, much of the Russian legislation of the 1990-1991 period continues to be important today. For this reason, many of the documents in Professor Butler's collection are still current. They are used as the legislative bases for subsequent developments, and to a large extent they remain the structure for Yeltsin's reform programs. In this respect especially valuable among the documents are the English translations of the April 1991 Land Code, the July 1991 Privatization Law, and the December 1990 Statute (also known as Regulations) on Joint-Stock Companies. These documents will remain important until Yeltsin gains more power and introduces more sweeping reforms.

The content of the volume is easy to describe. The collection begins with a group of documents creating the Commonwealth of Independent States in December 1991. This is followed by a translation of now largely inoperative Treaty on an Economic Community Yeltsin managed to push through in October 1991 as a countermove to Gorbachev's attempt to salvage the Soviet Union after the August 1991 Coup by bringing into existence a new union of the republics. The bulk of the book is taken up by English translations of Russian laws. They are arranged into seven sections dealing respectively with state sovereignty, state structure, property and privatization, company law, restrictive practices, foreign economic activities, and free economic zones.

As radical changes continue to take place in Russia, it is quite possible that soon many of the laws in this volume may become history. As long as they stay in force, this collection will remain a convenient English-language source for their texts.
