Understanding the process of shaping investor expectations is essential to describe and predict changes in the value of assets on the financial markets, especially stock prices on the capital markets and thus the value of companies listed on them. The main objective of this book is to include the investor expectations in the concept of enterprise value management and measurement of shareholders' value creation. It seems that the role of expectations as a determinant of investment decisions on the capital market requires a deep insight and highlights the importance of managing the expectations for creating value for shareholders in particular in the context of the financial crisis of 2007-2009. Studies have also shown that changes in expectations for long term profits have a significant and immediate impact on the share price.
