

Steps to answering a Constitutional law problem question:

(Please be aware you do not have to abide by the order as set out below. You may wish to consider whether there is a State law first. You may wish to consider the limits in a completely different order. Your approach will need to be guided by the specific question you are asked to answer.)

1. Is there a Commonwealth Act?
2. What is the source of authority for that law?
Characterise the Law. Important note: different sections in the Commonwealth Act may fall under different heads of power:
 - a) What are the tests and what are the cases for the power under which the law is characterised?
 - b) Does the Cth law satisfy those tests?
 - c) Is it possible to use severance or reading down to bring the law within power

3. Are there any Constitutional limits on the exercise of that power by the Commonwealth? Consider whether it falls foul of for example:
 - a) Implied Limits
 1. The Implied Freedom of Political Communication
 2. Melbourne Corporations principle
 - b) Express Limits
 1. S117
 2. S80
 3. S1(xxxi)
 - c) Other
 1. Chapter 3 (ie is it a valid vesting of judicial power or non judicial power, does it breach separation of powers etc.)
4. If yes can the law be read down or parts of it severed to avoid breaching those limits?
5. Is there a State Act?
6. What is the source of authority for that State Act?
7. Are there any Constitutional limits on the exercise of that power? See 3 above
8. Is the State law inconsistent with the Cth law – s109?

(By the end of the course all aspects of this process will have been covered.)

Tip Show ambition but also demonstrate loyalty and a clear career path within the firm

Tip Provide a personal and genuine reason that shows your dedication to the field
