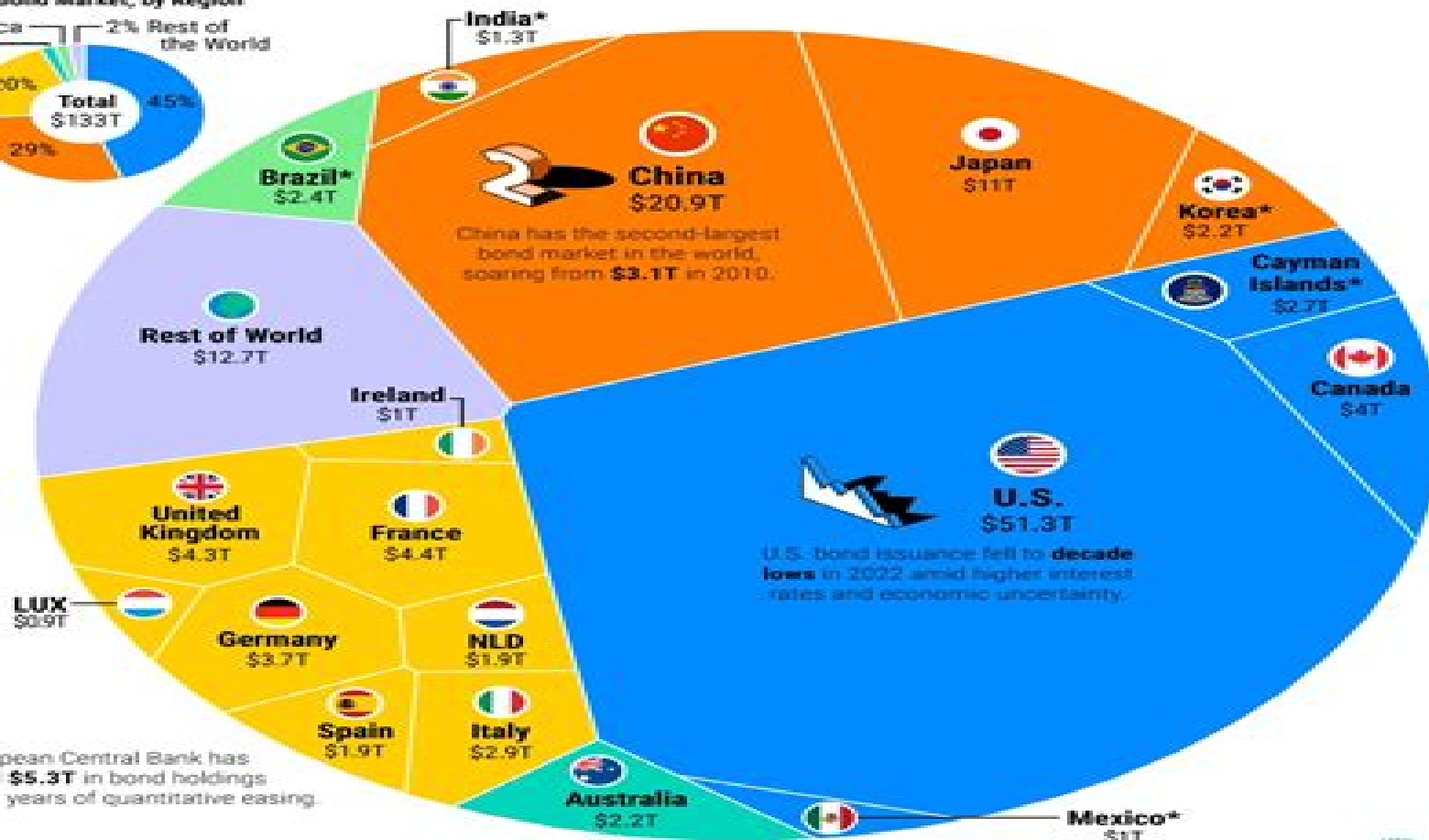
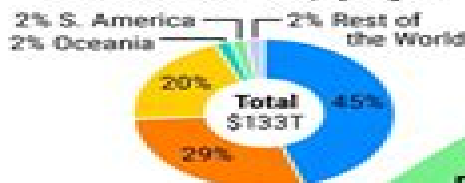
Together, the U.S. and China make up 55% of the global bond market. We show the largest bond markets in the world based on data from the Bank for International Settlements.
