- Colonists used courts to control local affairs
- **Supported interests and ideas of their communities**
  - Ex. **Laws in Massachusetts enforced Puritan's religious views (efforts to combine church and state)**
- Sometimes protected individual freedoms
  - Ex. **John Peter Zenger** – freedom of the press
    - **charged with committing libel (a false statement) against a public official**
    - Andrew Hamilton, his attorney, argued he could publish whatever he wanted as long as it was true
    - jury's verdict = not guilty
