Lee was a military genius who staved off inevitable Confederate defeat against insurmountable odds. Instead, the author contends that Lee was responsible for the South's loss in a war it could have won. Instead, as this book demonstrates, Lee unnecessarily went for the win, squandered his irreplaceable troops and weakened his army so badly that military defeat became inevitable. It describes how Lee's army took 80,000 casualties in Lee's first fourteen months of command while imposing 73,000 casualties on his opponents. Bonekemper argues that Lee's ultimate failure was his prolonging of the hopeless and bloody slaughter even after Union victory had been ensured by a series of events: the fall of Atlanta, the re-election of Lincoln, and the fall of Petersburg and Richmond. Finally, the author explores historians' treatment of Lee, including the deification of him by failed Confederate generals attempting to resurrect their own reputations.
