

Trial vs. Appellate Courts

- ▣ Trial courts hear evidence (documents, witnesses) and decide initial result.
- ▣ Judge or jury may decide
- ▣ Appellate courts do not hear direct evidence; they review the record of the lower court to determine if a “reversible” (harmful) error has occurred
- ▣ Usually an error of law that was likely to affect the outcome
- ▣ Appellate court decisions become *precedents* for future cases
