Tort law attempts to assign responsibility (termed <u>liability</u>) for these risks to those who create them and thereby induce individuals to <u>internalize</u> the <u>externalities</u> (the risks they impose on others)

The economic purpose of tort liability is to make individuals internalize the risk (potential harm caused by torts) and thereby induce individuals to invest in safety (to take precaution)

Much of the economic analysis of tort law deals with the design of efficient liability rules and determination of damages
