### When are Valuations needed?

- Takeovers (Price paid would be MV + a takeover premium)
- When setting a price for an IPO (Initial Public Offer)
- Selling 'private' shares
- When using shares as loan security
- When negotiating a sale of a private company
- For liquidation purposes

### What information helps Valuation?

- Financial statements
- Non-current asset summaries
- Investments held
- Working capital listing (debtors, creditors and stock)
- Lease agreements
- Budgets
- Current industry environment

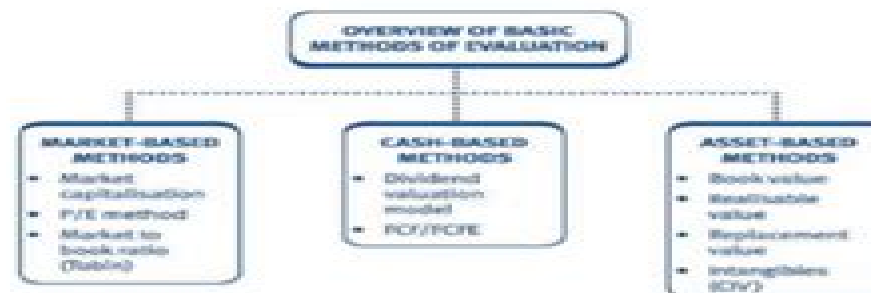
### What are the limitations of the information provided?

- Does the PPE need a costly revaluation?

- Has deferred tax been calculated appropriately?
- How has stock been valued?
- Are all debtors receivable?
- Are there any redundancy costs?

- What shareholding is being sold? Does it mean the business carries on?

### A. Valuation Method

#### Business valuation methods

1. Value the cash flows or earnings or dividends [Income based]
2. Value the Market-based Methods - forecast of future [Market (fair value)]
3. Asset-based method – what is actually has [Assets based]
