### USING THE ALWD CITATION MANUAL

Speed Cite is a quick reference tool to be used as a companion to the Third Edition of the *ALWD Citation Manual*. For more detailed information, use the Index, Table of Contents, or Fast Formats Locator to find material. For local court citation rules, consult Appendix 2. Consult the Manual's Web site, <http://www.alwd.org>, for updates.

### CITING CASES (RULE 12)

Include the case name, volume, reporter, initial page, pinpoint page(s), court, date, and any subsequent history: *Benson Mfg. Co. v. Overbeek Ins. Group*, 290 F. Supp. 2d 243, 244–245 (D.R.I. 2003), rev'd, 376 F.3d 8 (1st Cir. 2004).

#### Case Names

- Cite only the first-listed party on each side. Do not use “et al.” to indicate an omission. (12.20(c))
- For individual parties, generally include only the last name: Jose G. Juarez becomes *Juarez*. (12.21(d))
- For business and governmental entities, abbreviate words in the party's name per Appendix 3: National Chemical Company becomes *Natl. Chem. Co.* (12.20(e), (f))
- When a name includes two business designations, delete the second: Company, Incorporated becomes *Co.* (12.20(e)(7))
- Cite United States as *U.S.* (12.20(g))

#### Courts and Reporters

- **U.S. Supreme Court cases:** Cite *U.S.* when possible. Do not include a court abbreviation in the date parenthetical: *Reyn. v. Law*, 541 U.S. 509 (2004). (12.40(c))
- **United States Courts of Appeals:** Cite *F., F.2d, F.3d,* or *Fed. Appx.* Include the court abbreviation in the date parenthetical: *Kearney, Inc. v. Ingot Commission, Co.*, 393 F.3d 656 (8th Cir. 2004). (12.6 & App. 4)
- **United States District Courts:** Cite *F. Supp.* or *F. Supp. 2d*. Include the court abbreviation in the date parenthetical: *Sonsteg v. Moran*, 71 F. Supp. 2d 475 (E.D. Pa. 1999). (12.6 & App. 4)
- **State courts:** Unless otherwise required by local court rule (App. 2), cite the West regional reporter: *Fletcher Hill, Inc. v. Crockett*, 872 A.2d 292 (Vt. 2005); *Dawson v. Miss, Dept. Marine Resources*, 892 So. 2d 837 (Miss. App. 2005). (Rule 12.6 & Chart 12.7 (Web))
- **Parallel citations:** Cite both the official reporter and West regional reporter if local rules require parallel citations in briefs to their courts. Omit the court abbreviation from the date parenthetical: *Jackson v. Gregory*, 160 Ohio App. 3d 258, 826 N.E.2d 900 (2d Dist. 2005). (12.40(d) & App. 2)

#### Special Citation Forms

- **Dissents and concurrences:** *Lopez v. Monterey Co.*, 525 U.S. 286, 296 (1999) (Thomas, J., dissenting). (12.41(a))
- **LexisNexis and Westlaw:** Add the database identifier, pinpoint reference to star page, and exact date: *Jackson v. Mich. St. U.*, 2005 WL 1632295 at \*3 (Mich. App. July 14, 2005); *Bouffard v. Larrot*, 2004 Va. App. LE005 996 at \*\*1–2 (Dec. 7, 2004). (12.42)

#### Short Citation Formats (11.3 & 12.21)

- Use *id.* to refer to the immediately preceding authority.
- When all or part of the case name appears in the preceding sentence, use: 444 S.W.2d at 19. When the case name does not appear in the preceding sentence, use: *Nixon*, 719 N.E.2d at 433–434.

### CITING CONSTITUTIONS (RULE 13)

Include the name of the constitution and the pinpoint reference. Do not include the date for a constitution currently in force: U.S. Const. amend. XIX, § 2.

### CITING STATUTES (RULE 14)

- **Federal statutes:** Cite *U.S.C.* when possible. Otherwise, cite *U.S.C.A.* or *U.S.C.S.*: 28 U.S.C. § 1679 (2000); 28 U.S.C.A. § 1679 (West 2004); 28 U.S.C.S. § 1679 (Lexis 2004). (14.1)
- **State statutes:** Cite the official code when possible. Consult Appendix 1 for each state's specific format. (14.4)
- **Electronic format:** Include the database provider and “current through” date: *Del. Code Ann. tit. 13, § 101(a), (d)* (Westlaw current through 2005 1st Reg. Sess.). (14.5)
- **Short citations:** Use *id.* when citing the immediately preceding authority. Otherwise, use 28 U.S.C. § 1679, or § 1679. (14.6)

### CITING RULES (RULE 17)


For rules of court, procedure, evidence, and ethics, include the code abbreviation and rule number: *Fed. R. Civ. P. 30*; *Fla. R. Crim. Evid. 403*.

### CITING BOOKS AND TREATISES (RULE 22)

Include the author(s), title, pinpoint reference, editor(s) (if any), edition (after the first), publisher, and year: Lynn M. LoPucki & Elizabeth Warren, *Second Credit: A Systems Approach* 700 (4th ed., Aspen Publishers 2002).
