Wesley's concerns to be incorporated into the new schema without sacrificing his core commitments. The final chapter sketches the doctrines of assurance and perfection in the new framework Assurance is based on religious faith and on self knowledge both empirical and psychological and perfection is understood in a more teleological context.
