AIDS researchers have been able to conduct the kind of basic research needed to understand the biology of the virus and, thus, develop ways to combat HIV's teracious will to live. Its ability to mutate almost at will makes it a formidable foe, especially for those championing vaccine development.

Now 15 years into the AIDS pandemic, the major challenge for health professionals working with those afflicted is trying to keep up with the research so its findings can be used to assess the value of available therapies as well as to provide support and comfort to those who are terminally ill.
