There are at least **three types of variables** present in the relationship. The first is a **control variable** (age) and this shows the tendency to **ignore** the other two. The second is a **mediator variable** (the extent to which the tendency to smoke is reduced by the extent to which the tendency to exercise is reduced) and this is the **mechanism** by which the relationship between the two variables is brought about. The third is a **moderator variable** (the extent to which the relationship between the two variables is strengthened or weakened) and this is the **condition** under which the relationship between the two variables is brought about.
