

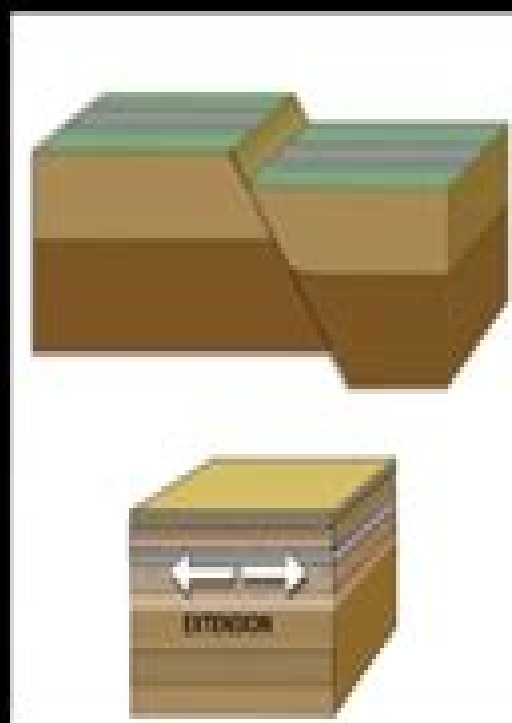

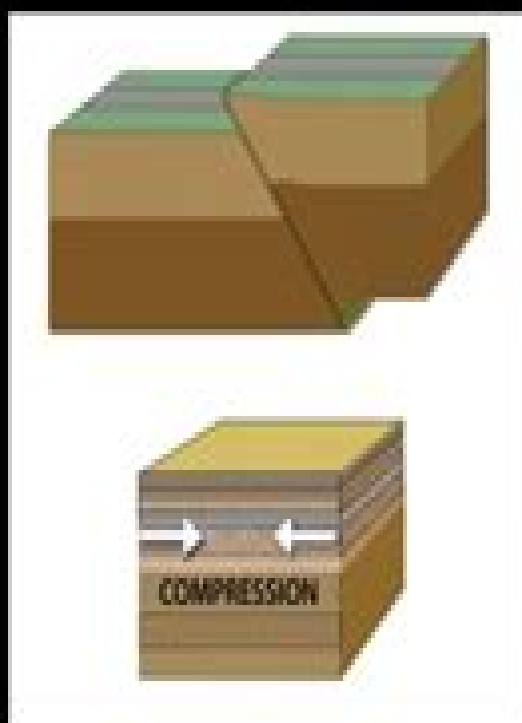


Three Basic Fault Types

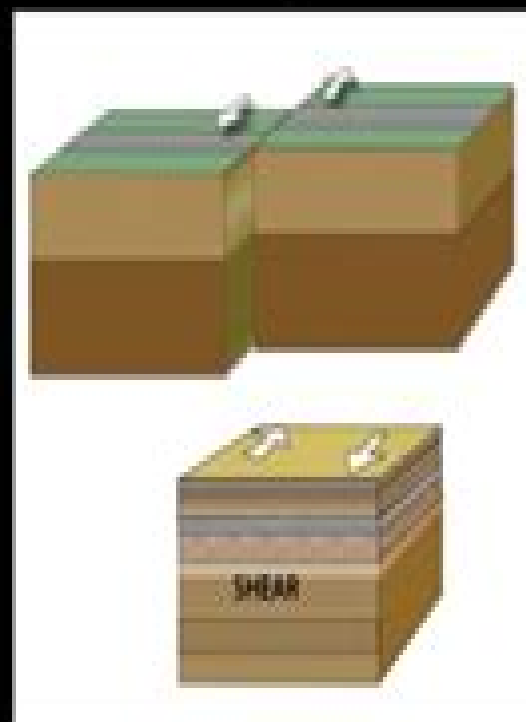
Normal fault
