

WHAT IS A STOCK?



All companies need money to start or grow their business. One way a company can raise money is to divide itself into little pieces and sell the pieces to investors through what is known as an Initial Public Offering, or IPO. Each little piece is called a share of stock.



The value of a stock is essentially determined by the principles of supply and demand. If many people want to buy stock in Company X, the value will go up. Conversely, if few people desire to own stock in Company X, the value will decrease.



After the company sells their initial offering of stock to the public, anyone desiring to purchase shares of the company must buy them from someone who has them. These people are called brokers, which charge fees for facilitating trades.

Each share of stock is entitled to a cut of the company's profits.



By owning a share of stock, you own a portion of the company.

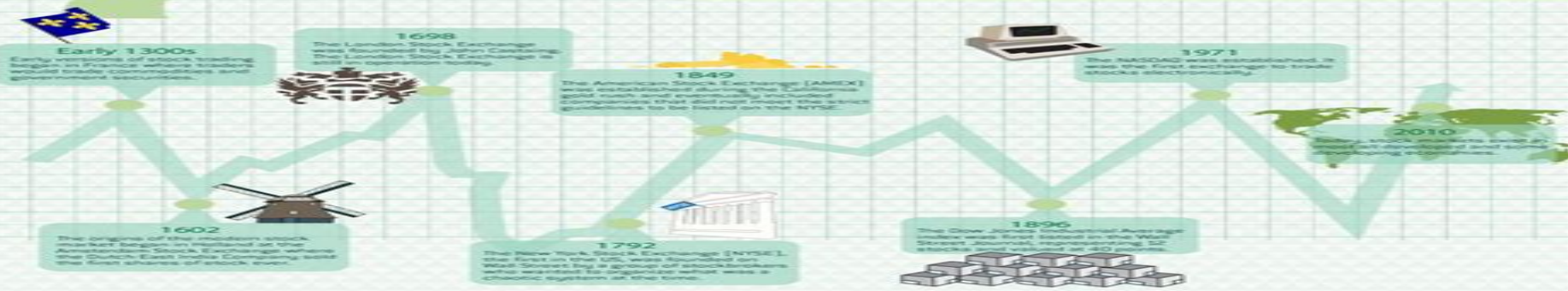
When a corporation earns a profit or surplus, that money can be put to two uses. It can either be re-invested in the business, or it can be paid to the shareholders as a dividend. Many corporations retain a portion of their earnings and pay the remainder as a dividend.



For a given stock company, the amount of dividend is fixed.
