Introduction

PAS12 prescribes the **accounting for income taxes**.

- For purposes of PAS12, **income taxes** refer to **taxes based on taxable profits**.
- The **income tax expense** reported in the statement of comprehensive income may be different from the amount of income tax required to be paid to the **Bureau of Internal Revenue (BIR)** because of the differences in the computation of taxes based on the PFRSs and Philippine tax laws.
 - This **results in permanent and temporary differences**.
