Introduction

PAS12 prescribes the accounting for income taxes.

- For purposes of PAS12, income taxes refer to taxes based on taxable profits.
- The income tax expense reported in the statement of comprehensive income may be different from the amount of income tax required to be paid to the Bureau of Internal Revenue (BIR) because of the differences in the computation of taxes based on the PFRSs and Philippine tax laws.
 - This results in permanent and temporary differences.
