

# Juvenile Court Responses to Status Offenders

- Gender dynamics – see, Hagan, “Power Control Theory” -- thread from “immorality” to pregnancy, girls were often detained
- “Gendered administration” of status offenses (see Feld)
- Detention as “front end” punishment, largely unregulated both in its use and its conditions for several decades
- Conflict with diversionary theory of juvenile court ?
- Court-ordered restrictions on freedom of movement
- Violation of “valid court order” is delinquency, subject to full force of juvenile court sanctions and interventions
