

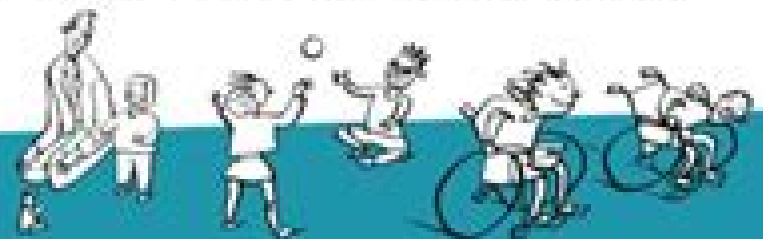
Special education provision in schools
