## BLACK LAWS OF 1807.

SEC. 1. Be it enacted by the general assembly of the state of Ohio, That no negro or mulatto person shall be permitted to emigrate into and settle within this state, unless such negro or mulatto person shall, within twenty days thereafter, enter into bond with two or more freehold sureties, in the penal sum of five hundred dollars, before the clerk of the court of common pleas of the county in which such negro or mulatto may wish to reside (to be approved of by the clerk) conditioned for the good behavior of such negro or mulatto, and moreover to pay for the support of such person, in case he, she or they should thereafter be found within any township in this state, unable to support themselves. And if any negro or mulatto person shall migrate into this state, and not comply with the provisions of this act, it shall be the duty of the overseers of the poor of the township where such negro or mulatto person may be found, to remove immediately, such black or mulatto person, in the same manner, as is required in the case of paupers.

SEC. 2. Be it further enacted. That it shall be the duty of the clerk, before whom such bond may be given as aforesaid, to file the same in his office, and give a certificate thereof to such negro or mulatto person; and the said clerk shall be entitled to receive the sum of one dollar for the bond and certificate aforesaid, on the de-

livery of the certificate.

SEC. 3. Be it further enacted, That if any person being a resident of this state, shall employ, harbor or conceal any such negro or mulatto person aforesaid, contrary to the provisions of the first section of this act, any person so offending, shall forfeit and pay, for every such offence, any sum not exceeding one hundred dollars, the one half to the informer, and the other half for the use of the poor of the township in which such person may resid, to be recovered by action of debt, before any court having competent jurisdiction, and moreover be liable for the maintenance and support of such negro or mulatto, provided he, she or they shall become unable to support themselves.

SEC. 4. Be it further enacted. That no black or mulatto person or persons, shall be reafter be permitted to be sworn or give evidence in any court or record, or elewhere in this state, in any cause depending, or matter of controversy, where either party to the same is a white person, or in any prosecution, which shall be instituted in behalf of this state, against any white person.

Sec. 5. And be it further enacted. That so much of the act, entitled "An act to regulate black and mulatto persons," as is contrary to this act, together with the sixth section thereof be, and the same is hereby repealed.

This act shall take effect and be in force, from and after the first

day of April next.
