exclusionary in its intellectual or methodological scope. Eulau's scholarly curiosity is quite clearly provoked by a variety of topics, problems, and approaches. The breadth of these interests might tempt some to suggest that there is little novelty in his view that the study of politics is necessarily concerned with micro-macro problems. Indeed, Eulau undoubtedly would agree, and such a criticism would miss the point.

Eulau's contribution is to focus our attention on the micro-macro manifold as the primary organizing principle for political analysis. The clear implication is that the study of politics is inherently concerned with these dilemmas because politics loses meaning unless it is concerned with interdependent actors and institutions—who are engaged at multiple levels of meaning. Whether it be citizens who organize a neighborhood watch, or congressional representatives who lose touch with their constituencies, or federal systems that differentially allocate authority, the defining ingredient of politics is the interdependence of actors, and this interdependence produces important multilevel implications.

Needless to say, a great many political scientists focus on these problems. Studies of social influence in political psychology as well as studies of new institutionalism in political economy share a common concern with multiple levels of political analysis. Eulau's contribution, based on his own intellectual journey, is to recognize that an explicit and self-conscious focus on the micro-macro manifold creates its own rewards. Eulau is not the first scholar to demonstrate the importance of the part-whole problem, but it is noteworthy that his own journey produces this demonstration in the context of the behavioral persuasion. Many political scientists who came of age in this tradition remember being trained within the context of the rectangular array, a matrix of observations defined around a common unit of analysis. Eulau forces us to see the rectangular array as nothing more than a convenient means for organizing information and observation, and he certainly forces us to discard it as a theoretical device for understanding politics.

Aquinas: Moral, Political, and Legal Theory. By John Finnis. Oxford: Oxford University Press, 1998. 385p. \$52.00 cloth, \$18.95 paper.

It has been four decades since the publication of the last book-length study in English of the social thought of St. Thomas Aquinas (Thomas Gilby, Principality and Polity, 1958). In that volume, Gilby sought to locate Aquinas's doctrines within the historical terrain of classical and medieval Western thought. By contrast, John Finnis's new survey of St. Thomas's contributions to moral, legal, and political philosophy is almost entirely lacking in historical bearing. A noted British legal philosopher and defender of natural law, Finnis develops his interpretation by means of a logical reconstruction of the internal coherence of Aquinas's teachings, identifying a small number of principles (e.g., reasonableness, natural equality, love of neighbor) that ground the larger project of St. Thomas's social theory, as expressed in the vast array of theological, moral, and political writings he composed over the course of his career.

The fruits of the Finnis approach to Aquinas are mixed. On the positive side, the book does a superb job of framing St. Thomas's political theory in the setting of his theology and, especially, moral philosophy. While scholars often pay lip service to the importance of ethical and religious considerations in the understanding of Aquinas's political doctrines, they have seldom established the connections so extensively and carefully as Finnis. Readers are shown conclusively the impossibility of achieving a full and balanced picture of St. Thomas's reflections on community and government without locating them in his system as a whole. Indeed, only four of the volume's ten chapters concentrate on standard topics of political theory; the rest examine such matters as Aquinas's methods, his philosophy of the person (mind and action), and his conception of the ends and ultimate meaning of human existence.

Finnis should be given special credit for the clarity of his presentation as well as for the thoroughness of reference to primary texts. He organizes St. Thomas's teachings in a manner accessible to a modern reader, having combed the corpus of work (including the underused commentaries on books of scripture and Peter Lombard's Sentences) in order to construct a complete account of the subject. Interestingly, Finnis concludes that St. Thomas adopted a relatively modest and constrained view of the appropriate purposes of government and law: The role of the community and its rulers is to promote peace and justice rather than to instill ethical or spiritual qualities in members of society. Crucial to this reading is the point that the "public good" (that good which pertains to political affairs to realize) forms for Aquinas but one limited dimension of the wider "common (human) good" (see p. 252). Finnis thus insists that the commonplace distinction between Augustinian and Aristotelian/Thomist visions of the proper role of the state and its relation to the individual has been overdrawn (p. 248, n. 148).

On this insight turns much of Finnis's case for not only the "fundamental superiority" of Aquinas's social theory but also its continuing relevance to modern political issues (p. vii). (It is not an accident-although it may be an irony-that the volume has been included in a newly launched series, "Founders of Modern Social and Political Thought.") The political ideas Finnis discovers in St. Thomas prove generally to be lessons congenial to Finnis's own intellectual and political program. On questions such as capital punishment, warfare, constitutionalism, legality, resistance to unjust authority, capitalist enterprise, and the like, Aquinas is revealed to advocate (or at least sympathize with) positions commensurate with those Finnis himself is known to favor. In instances in which St. Thomas's opinions cannot be construed so as to support enlightened thinking-as with his pronouncements about woman, slavery, economics, and heretics-Finnis either dismisses them (usually in an endnote) asunfortunate (and unnecessary) accretions of Aquinas's historical milieu or reconfigures them according to a logical measure of "what he should have said" (p. 209). In opting to construct a systematic synthesis accessible to contemporary readers, Finnis filters out inconvenient elements of his subject matter. Little of the medieval content remains of the thinker who is so commonly (perhaps too commonly) regarded as the quintessential spokesperson for the philosophy of the Latin Middle Ages. Historical judgments-this time ours, not St. Thomas's-are thus reintroduced through the back door. There is a certain disingenuous quality to such an assiduously ahistorical mode of interpretation.

The (psuedo-)ahistoricism of Finnis's book is particularly unfortunate in light of the large body of scholarship, published since Gilby wrote in the mid-1950s, useful for appreciating Aquinas's unique place in the history of scholastic social thought and ethics. Cognizance of James Blythe's 1992 book (Ideal Government and the Mixed Constitution in the Middle Ages) on the medieval mixed constitution, Odd Langholm's 1992 analysis of economics in the schools (Economics in the Medieval Schools), Brian Tierney's many essays on
