It emphasize on contradiction and motion which is especially based on Newton's third law of motion (rule of action and reaction). So law, according to Marxism, is an instrument of class struggle, dictatorship and state power. Socialist Law is an instrument of the dictatorship of the proletariat and the socialist state power till the withering out of it. Socialist Law is based on Marxist economic ideology. Policy of planned economic development is effective.
