

LA CLÁUSULA DE CONCIENCIA Y EL DERECHO A LA INFORMACIÓN

CONTEXTO HISTÓRICO-JURÍDICO: NUEVA MIRADA

Resumen: El derecho a la información se realiza en gran medida gracias a la labor del periodista profesional quien trabaja la mayoría de las veces en relación de dependencia. Un aspecto que hace a la garantía de éste es la relación de dependencia en la cláusula de conciencia. ¿Es un derecho sólo del periodista y de los trabajadores de prensa o del sujeto universal de la información? Hay que poder distinguirse —dentro de la cláusula de conciencia— dos aspectos: uno pasivo, para los periodistas, y otro de carácter activo por cuanto otorga el derecho de tomar iniciativas voluntarias destinadas a advertir sobre los peligros potenciales o a denunciar algunas prácticas que atentan contra la salud o la ecología.

Derecho a la Información y Cláusula de conciencia

El derecho de información comprende tres tareas conforme el artículo 13 de la Convención Americana de Derechos Humanos, a la cual nuestro país incorpora como parte de nuestro ordenamiento jurídico en 1984 por ley 23054 y diez años más tarde toma jerarquía constitucional con la reforma de nuestra carta magna en 1994 a través del artículo 75 inc. 22. Estas actividades son:

- de *buscar*, asignada principalmente al sujeto profesional —llamado comunicador social, o periodista—,
- la de *difundir* asignada al sujeto empresario, y
- la de *recibir*, propia del público en general

Esta última tiene un componente prioritariamente pasivo en contraposición de las dos anteriores que son activas.
