- Current industry environment

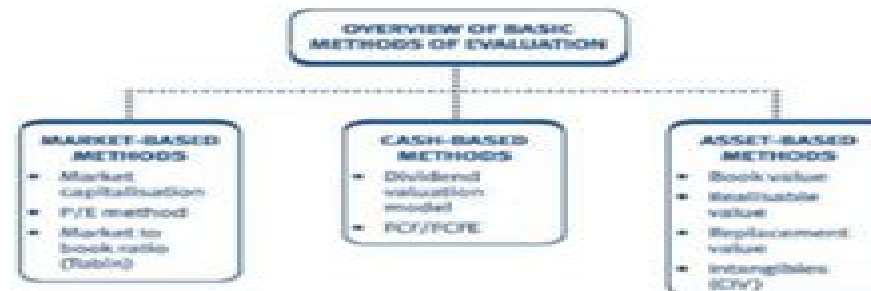
What are the limitations of the information provided?
