The material analyses not only the cross-selling of each other's products and the blurring of the market boundaries but also the diversification, collaboration and integration on all other levels and functions. New conceptual tools, the financial conglomerates control board, are developed to provide a more in-depth comparison of the many cases of this international trend.
