1

Offer

A proposal made with clear terms and communicated effectively.

2

Acceptance

Unconditional agreement to the terms of the offer, made through appropriate communication.

3

Consideration

An exchange of value, which can be monetary or non-monetary, between the parties.

4

Legality

The contract's subject matter must comply with the law and not involve illegal activities.

5

Capacity

Both parties must have the legal competence and authority to enter into the contract.
