1. Maternity Leave

1.1 Eligibility

 The Employee is eligible for maternity leave in accordance with the applicable laws and regulations. Eligibility typically extends to female employees who are pregnant or have recently given birth.

1.2 Duration of Maternity Leave

 The Employee is entitled to a period of paid maternity leave, which shall commence on the date of childbirth and continue for a period of 12 weeks. The duration of maternity leave may be extended in case of complications or other qualifying circumstances as per the relevant laws.
