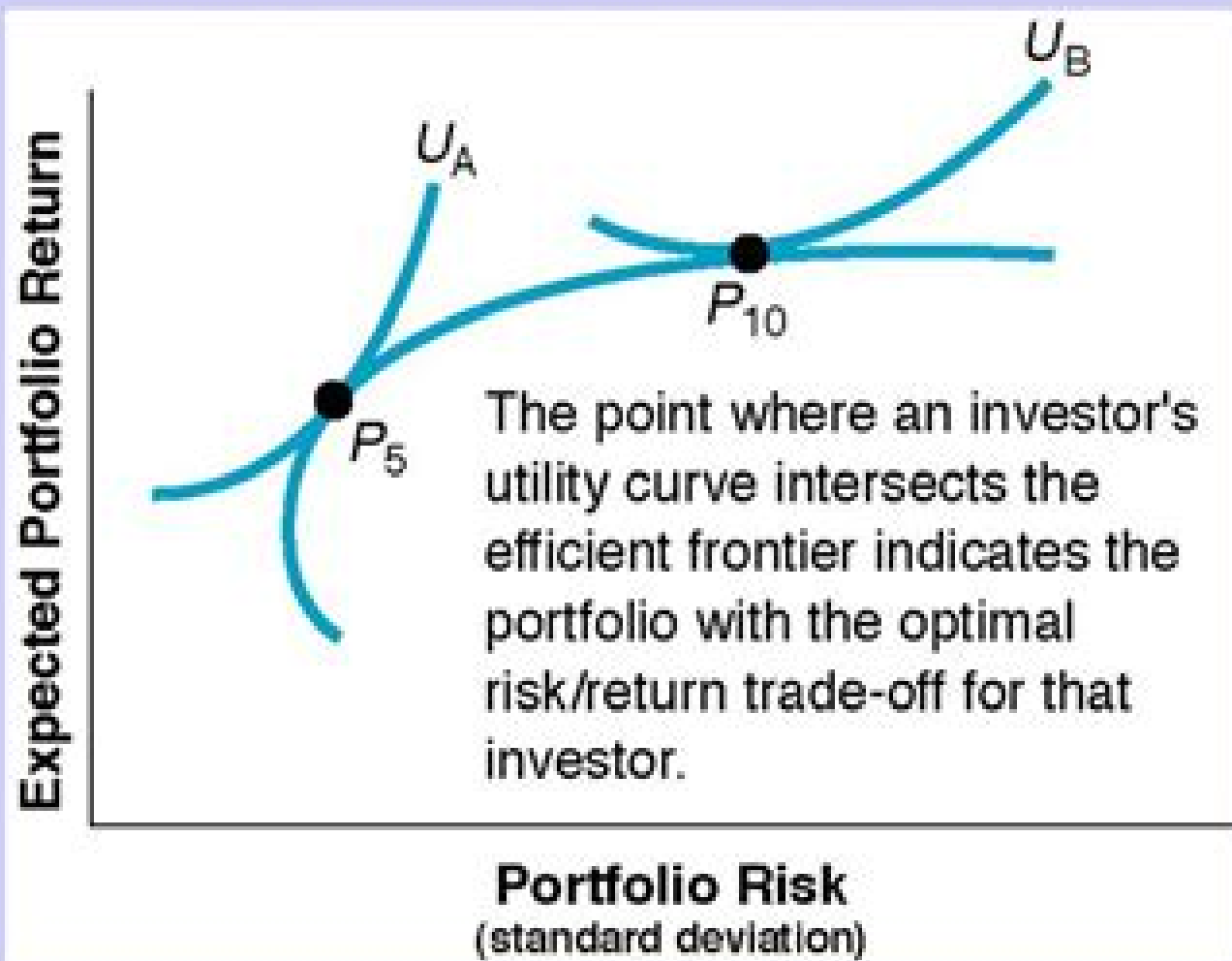


Figure 18.2 – Efficient Frontier and Utility Curves for Investors A and B
