

proteins); five chapters deal with the inheritance of known genes; there is one chapter on immunogenetics and one on gene sequencing in relation to the fowl; one chapter covers both the transmission genetics and the molecular genetics of muscle, nervous and skeletal tissue and one chapter deals with quantitative genetics and selection in practice.

A book as tightly packed as this will not be of great interest to the poultry fancier concerned with the inheritance of particular genes. The quantitative geneticist who is faced with the task of breeding better chickens will need the more extensive review by Crawford. That leaves the student who is obliged to learn something about poultry genetics and the research scientist who knows about genetics but wants to find out about the fowl. For both these groups it will prove a valuable text, although a little more could have been taken for granted. For example, the author has included an explanation of variance and covariance in two pages and of heritability and variance components in three more. These explanations are unnecessary for those who have taken courses in statistics and genetics, but are too brief for anyone who lacks a basic training in these subjects. However, these are difficult matters to judge when seeking to condense a large body of knowledge into a small compass without giving the reader indigestion. This is certainly a book which needs to be on the shelf of all those who teach or research the fields of genetics or poultry science.

*Countryside Planning Policies for the 1990s*, by A. W. Gilg. x+250 pp. Wallingford: CAB International (1991). £40.00 or \$76.00 (hardback). ISBN 0 85198 744 3.

To produce this volume, the author read 1200 references and about 600 of these are included. This huge volume of source material is summarized by giving briefly the salient features of each reference. The information is largely undigested, making the book an encyclopaedic reference work, a starting point for other studies. The book is divided into two parts: 'A Policy and Political Context for the 1990s' and 'Policy Proposals by Subject Area'. The first part contains three chapters, the first of which is likely to be particularly unfamiliar to agricultural scientists, as it covers political theory and the changes of the post-1979 era. Policy options are then discussed against this political background. Chapter 3 differs from the remainder of the book in that it is a review by the author instead of a collection of references; it covers the legislative and institutional changes of the 1980s including, notably, agricultural policy in both the UK and EC, forestry and the environment. This chapter packs a great deal of information into a small space

and is an extremely useful update for all those scientists who find it difficult to keep track of governments' activities. Part Two consists of eight chapters on: environment, the countryside as a whole, agriculture, forestry, land use planning, socio-economic issues, conservation and recreation with, finally, an appraisal looking forward into the next decade. The emphasis in these chapters is on planning aspects, but many other rural interests and points of view are well served.

Whatever your interest in the rural scene, this volume will have something for you. Because of its exceptionally wide scope it is likely to bring to your notice papers and ideas which you might not otherwise have discovered. This is a most useful book; I particularly recommend the Chapter 3 review of the 1980s.

*Rice Insects: Management Strategies (Springer Series in Experimental Entomology)*, eds E. A. Heinrichs & T. A. Miller. xiii+347 pp. Berlin-Heidelberg-New York: Springer-Verlag (1991). DM 198.00 (hardback). ISBN 3 540 97490 3.

Rice is one of the world's most important food plants and insect pests cause considerable yield losses. As such, it is a significant model crop with which to develop insect management strategies. This book is, however, concerned more with the methodologies of the various aspects of rice insect management than the strategies themselves.

There are ten chapters covering: Crop loss assessment, Economic thresholds, Mosquito population dynamics, Pheromone identification, Long-distance migration, Predators and parasitoids, Variability in insect populations, Chemical basis of host plant resistance, Tissue culture techniques, and Systems analysis. There is some overlap in the content of the chapters, especially the first two and the final one, and there has been little effort to edit out repetition or to cross-reference where necessary. There is reference to another book to be published in 1991 (*Biology and Management of Rice Insects*, Wiley-Eastern, ed. E. A. Heinrichs) which would seem to overlap considerably with the content of this book.

Some of the chapters are excellent reviews of the methods available to study various subject areas, in the context of rice insect management, especially those on crop loss assessment, economic thresholds, long-distance migration and predators and parasitoids. All of the chapters were written by established experts in the field but the book, in common with most multi-author books, does have a disjointed feel about it. In addition, some of the chapters are relevant to the high technological input
