- 22nd Amendment: **Term limits: It limits the president to serve more than 2 terms and no one can be president for more than 10 years.**
- 22nd Amendment: **Presidential succession: The vice president takes over the president if the president can no longer serve. And if the vice president becomes a president they get to choose a new vice president.**
- Impeachment: **The process to put the president on trial for a crime.**
- Electoral College: **The system to elect the president state by state.**
- Cabinet: **The 15 leaders that help run the executive branch.**
