- Volunteer Protection Act of 1997
  - Immunity for volunteers serving nonprofit organizations or government for harm caused by the acts and omissions if:
    - The volunteer was acting within the scope of his or her responsibilities
    - The volunteer was properly licensed, certified, or authorized to act.
    - The harm was not caused by willful, criminal, or reckless misconduct, gross negligence or a conscious, flagrant indifference to the rights or safety of the individual harmed
- Let your Site Coordinator know if you suspect fraud
  - Handwritten or altered W-2s
  - Undocumented earnings that lead to refundable credits
  - Similar returns or suspicious activity
