- Current industry environment

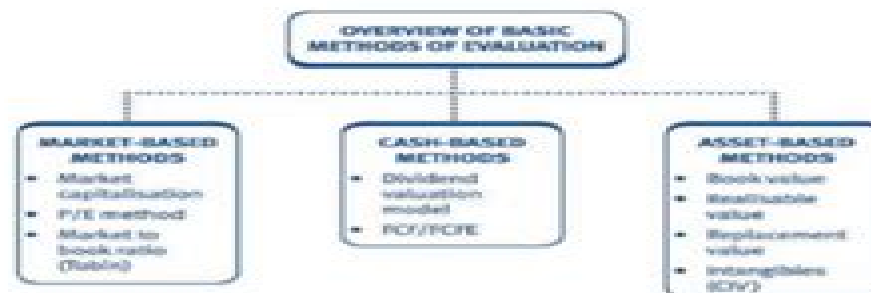
What are the limitations of the information provided?

3. Asset-based method – what is actually has [Assets based]
