rule of customary international law with an erga omnes effect Due to the lack of any objections and its fundamental value for humankind this regulation can also be considered a new peremptory norm of international law ius cogens While the sovereign equality of States recognises States freedom to decide if and how to enter into a given obligation States can also waive this freedom If States accepted a legally binding obligation they are thus bound to it Concerning the specific content of Art 192 UNCLOS a methodical interpretation concludes that only the adoption of legislative measures national laws and international agreements suffices to comply with the obligation to protect and preserve the marine environment which is confirmed by the States practices and relevant jurisprudence When applied to a specific geographical area legislative measures to protect the marine environment concur with the definition of Marine Protected Areas Nonetheless as the obligation applies to all waters the Grotian principle of the freedom of the sea dictates that the restriction of activities through the designation of Marine Protected Areas on the one hand must be weighed against the freedoms of other States on the other To anticipate the result while all other rights under the UNCLOS are subject to and contingent on other regulations of the UNCLOS and international law only the obligation to protect and preserve the marine environment is granted absolutely and thus outweighs all other interests
