Vance later to die in the feud as a friend of the Hatfields was the one who murdered Harmon McCoy Whoever killed Harmon McCoy is unknown for sure even to this day but one thing is sure his death created ill feeling between the McCoys and the Hatfields from the McCoy corner of course A third cause of the feud was a family quarrel which wound up in the court of a justice of the peace That was eight years after the Civil War had ended In those days in the rugged regions of the Tug the people let their hogs run loose and fatten on the mast of nut bearing trees chestnut acorn hazel and other trees
