The paper describing that review finally was published in 1974 after a long and tortuous process of review at several journals Several reviewers felt that such attempts to improve use amounted to interference with the patient's physician to do what was best Others felt that such programs focused incorrectly on a subject other than treating the current patient Fortunately today it is clear that antimicrobial resistance results in major part but not entirely from the ways that we use antimicrobial agents and that the ov all interests of patients in general as well as those of society are well served by efforts to use these drugs as well as possible
