In this regard, the analysis of various cases in relatively recent jurisprudence shows a pursuit for new forms of interpretation and application and even updates to the methodologies of analysis and of applicable legislation in order to strike a balance between intervention to curb anticompetitive practices to the extent necessary for protecting competition without resulting in undue interference in the involved markets or in disincentives to innovation. Notions of relevant market, theories of harm, and standards of consumer welfare or protection traditionally adopted by antitrust authorities are under study and may be revised. The heterogeneity of legal systems in different jurisdictions is another complicating factor for national authorities in the analysis of conduct practiced by companies with market power internationally.
